The Parade Route begins at Dickson County High School, exiting onto North Charlotte Street, turns left at McFarland, then right onto Highway 48 continuing down Main Street, takes a left before the Train Depot on Railroad Street, another left onto Church Street, followed by a right on East College Street, ending with a left on Academy Street and disbanding at Dickson County Middle School.
